REPORTS Alesha Porter, Pioneer Elementary Principal, gave an update on what is happening at

Pioneer Elementary. She went over the data from her school and spoke about how that drove their academic goals. Porter showed the Makerspace that Pioneer is offering at lunchtime to students and she spoke about the different opportunities that students at Pioneer Elementary are given. Lacey McNay, Elementary Teacher, spoke about the 7

different teams of Destination Imagination students that Pioneer has this year.

Elizabeth Averill, Quincy High School Business Education Teacher, introduced a group of students that spoke about the process that they underwent to find the new district-wide Jackrabbit mascot/logo. They described the different logos that they

looked at and described how they determined the one that they selected.

Cynthia Diaz and Taylor Thomsen gave the Student Board Representative Report. Diaz and Thomsen updated the Board on the upcoming High School activities and

athletic events.

Kathie Brown, Director of Whole Child, gave a report on the Student Health Center. She updated the Board on the recent visit to the Walla Walla Student Health Center. Brown spoke about the group realization that the student health center was actually more of a health care coordination that will help students and families utilize more referral services to different local providers.

Jon Wright, Special Education Director, gave a report on Special Education. Jon spoke about what the Special Education department is doing to close the achievement gap amongst special education students. Various special education teachers spoke about what is going well in their classrooms and what they see as the key to success for their students.

Victoria Hodge, Federal Programs Director, gave a report on Parent Partnership. Hodge spoke about the importance of making connections with community and parents in the promotion of the student success and wellness. Katia Perez-Chavez, Parent Engagement Coordinator, and Maria Valle, Family and Community Outreach Coordinator, spoke about how the different programs are strategies in getting families involved. Perez-Chavez and Valle also spoke about the next steps in cultivating parent partnerships. Tessa Poortinga, Social Worker, told the Board about her role in creating relationships with students and parents and how collaboration will help.

Amy Torrens-Harry gave the Board an update on the Math curriculum adoption and implementation.

John Boyd gave the Superintendent Report. Boyd spoke to the Board about the UW band bus accident and how the community stepped in and supported those students. Boyd announced that the Quincy School Board was named again this year as a Board of Distinction.
