his ideas on how to grow the music program for the district and how he feels the

staffing for the program is inadequate.

Janice Flynn, parent of a high school band student, spoke to the Board about her experience with Mr. Sherman's program asked them to support him in his requests.

Rolly Ronish, parent of a high school band student, also spoke to the Board about his

child's experience and also encouraged the Board to support Mr. Sherman.

He announced that Pioneer Elementary's Camille Jones was awarded Regional Teacher of the Year which will put her in the running for State then National awards. Boyd spoke about the recent donation by the Paul Lauzier Foundation to the Mt. View Elementary for a new playground structure. He also spoke about the

recent Ed Specs work that has been going on with George and the current Jr High.

Alex Ybarra gave the Board Leadership and Development report. Ybarra spoke about all of the successes that Quincy School District has had this year. He also touched on the

Equity Conference's emphasis on maximizing the opportunities for all kids.

Shayla Appling and Carla Beltran gave the Student Board Representative report.
